As per the discussion in the meeting of Board of Studies in Economics, it was proposed to conduct a Workshop at Adarsh College, Badlapur on Revised Syllabus of MA Part-II CBCS to be made effective from 2017-2018 to discuss & deliberate on the various Choices/alternatives and group of Courses to be offered to the students appearing for MA Part-II in the year 2017-2018 as per revised system. The workshop date was finalised as 9th March 2017, as communicated to all the colleges through letter and WhatsApp media.

In the absence of Dr.Neeraj Hatekar, Chairman Adhoc B.O.S.,the workshop was conducted by Dr.Mrs.Vaidehi Daptardar, Principal Adarsh College & Member of B.O.S. using the detailed Regulations for the CBCS for Master of Arts and the Syllabus options related material sent by Dr.Hatekar.

At the outset –Dr.Vaidehi Daptardar explained to all the professor the structure of MA I & II having 100 Credits. The analytical explanation with diagram was given about-(i)Core Subjects(ii)Electives(iii)Ability Enhancement Skill (iv)Interdisciplinary /Cross Studies and also about (v)Audit courses. It was informed that Audit Course is optional and to be conducted the as per demand of the students .The regulation related to it were clearly explained to all.

After an in depth discussion on the syllabi of various papers/courses,certain & addition & omission were suggested by the professors. The same are highlighted in green for omission & yellow for addition in the enclosed document for the consideration of B.O.S.

1)After thorough discussion on all 44 papers, following 8 papers were finalised, to be offered as Electives, out of which the students can select any 5 for Sem III (5x6=30 credits).

The Syllabi in respect of all the above mentioned 12 papers was finalized after discussion in detail considering the time constraints in Semester Exam Conduction of Internal Examination and other factors.

4)Important: Further, with reference to MA I Syllabus **a strong dissatisfaction** was expressed by the members over making Mathematics paper a compulsory one in Core Subjects. It was suggested that the Maths paper may be included in Electives for Sem III and any Economics paper may be made compulsory at Sem I and II in Math's place. The experience in terms of Result of Maths of Sem-I made them worried as the students strength may be adversely affected due to the same.

5) It was also suggested that the paper-setters for MA should be from among the faculty who know the structure in detail and those who attended the workshop.

The workshop was very successful in meeting its basic objectives It created confidence & satisfaction among teachers. They expressed gratitude for the same to Dr. Daptardar & also Adarsh College Arts & Commerce College.
